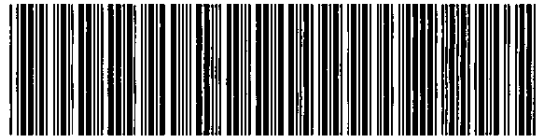


FIRST: THE Articles of Organization were filed on June 26, 2009 and assigned document number L09000058565.
