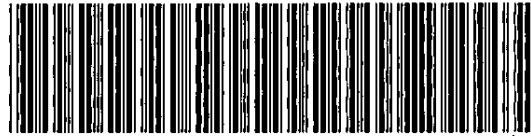

Article Two Registered Agent

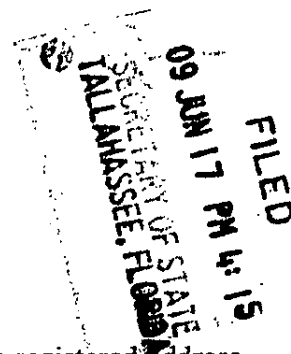
The initial registered agent of the Company is: Michael B. Hill. The registered address of the Company is: 9100 College Pointe Court, Fort Myers, Florida 33919.

Article Three Principal Office



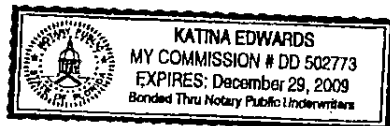


