**SECOND AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
JYM GENERAL PARTNER LLC**

Pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, the undersigned desiring to amend and restate, for the second time, the articles of organization of JYM GENERAL PARTNER LLC, a limited liability company (the "Company") duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on June 17, 2009 and assigned document number L09000058841. The undersigned confirms that these Amended and Restated Articles of Organization were unanimously adopted by the Sole Member of the Company by a Written Consent of the Sole Member of the Company on June 25, 2009. The purpose of this Second Amended and Restated Articles of Organization is to accurately set forth, in one document, the Articles of Organization of the Company, as such were amended and restated on June 18, 2009 and corrected on June 24, 2009. The following Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety as of the date hereof:

**ARTICLE I
NAME**


