ARTICLES OF ORGANIZATION OF THE MOMMYISTA, LLC

- 1. Name. The name of this limited liability company is THE MOMMYISTA, LLC, a Florida limited liability company (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
