**ARTICLE I**

Name and Duration

The name of this Limited Liability Company is EZ Maintenance & Cleaning , LLC (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual.

**ARTICLE II**

Principal Office

Purpose; Character of the Business

(b) obtaining financing and/or equity funds in order to acquire, develop and operate any property acquired or owned, directly or indirectly, by the Company in accordance with the Operating Agreement or other governing instrument;

(c) selling, leasing, subleasing, exchanging or otherwise disposing of, refinancing or additionally financing, all or any portion of the Company's interest in any

real or personal property acquired or owned, directly or indirectly, by the Company in accordance with the terms and conditions set forth in the Operating Agreement or other governing instrument; and

(d) performing all of its obligations under all agreements to which the Company is a party.

The Company shall not engage in any other business except as provided in the Operating Agreement or other governing instrument.


**ARTICLE VIII**Operating Agreement
