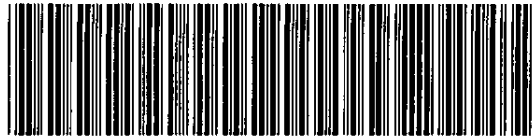



ARTICLES OF ORGANIZATION
FOR

ARTICLE I: NAME OF COMPANY

The name of this limited liability company shall be JEFF EPPERSON BUCK EVOLUTION, LLC.
