### ARTICLES OF ORGANIZATION

# The Attorney Financing Company, LLC

The undersigned person, seeking to form a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization.

- I NAME. The name of the limited liability company shall be: The Attorney Financing Company, LLC ("Company").
- II ADDRESS. The initial mailing address and street address of the principal office of the Company shall be 2631-A NW 41<sup>st</sup> Street, Gainesville, Florida 32606.
- III **DURATION**. The Company shall commence upon the date of filing of these Articles of Organization with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.

- V CAPITAL CONTRIBUTIONS. The members of the Company will contribute to the capital of the Company in cash or property. Each member may make additional capital contributions to the Company upon the unanimous consent of all the members.
