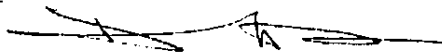
**ARTICLE VIII

The undersigned executed these Articles of Organization effective as of the 22nd day of June, 2009.

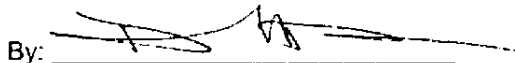
