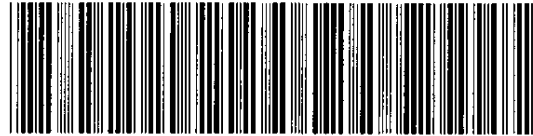

ARTICLES OF ORGANIZATION
OF
SUPER SUDS EXPRESS #4, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
Name and Principal Place of Business

The name of the limited liability company shall be **SUPER SUDS EXPRESS #4, LLC** (hereinafter the "Company"). The principal place of business and mailing address of the Company shall be 401 E. Virginia Street, Tallahassee, Florida 32301.

ARTICLE II
Duration
