ARTICLES OF ORGANIZATION

of

FIRST BEACHES INSURANCE, LLC

The undersigned, for the purpose of forming a limited liability company under the Plorida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS
