ARTICLES OF ORGANIZATION OF RIVERSIDE MEDICAL DIAGNOSTIC AND IMAGING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company shall be Riverside Medical Diagnostic and Imaging, LLC ("Company").
