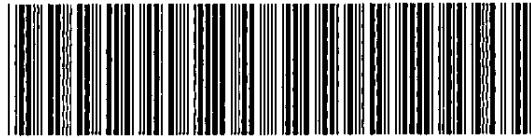

Article Three Principal Office


