#### ARTICLES OF ORGANIZATION

OF

The undersigned, acting as the organizer of LITTLE ENGLAND UTILITIES, LLCander the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Affices of Organization:

#### ARTICLE I - Name:

The name of the limited liability company is LITTLE ENGLAND UTILITIES, LEC (the "Company").

## ARTICLE VII - Initial Registered Agent and Office:

#### **ARTICLE VIII - Amendments:**

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written appropriate all Members of the Company.

#### ARTICLE IX - Indemnification:

In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a member or officer existing at the time of such repeal or amendment.

#### ARTICLE X - Continuation of Business:

Unless dissolved in accordance with the Company's Operating Agreement, the remaining Members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member.
