ARTICLES OF ORGANIZATION

of

MCKNIGHT CONSULTING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

The name of the limited liability company shall be McKnight Consulting, LLC (the "**Company**"). The mailing and street address of the principal address of the Company in Florida shall be 1505 1st Street South, #301, Jacksonville Beach, Florida 32250.

ARTICLE II

ARTICLE V**TERMINATION OF EXISTENCE**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

ARTICLE VI**MANAGER**
