**AMENDED ARTICLES OF ORGANIZATION
OF
SRDG, LLC**

Pursuant to Chapter 608, *Florida Statutes*, SRDG, LLC, a Florida limited liability company, adopts the following amendments to its Articles of Organization.

FIRST: The name of the limited liability company is SRDG, LLC.

SECOND: The Articles of Organization of SRDG, LLC were filed with the State of Florida on June 26, 2009, and were accepted on June 29, 2009, and bear Florida Document Number L09000062683.

THIRD: The Members wish to change the mailing address and principal office of the Company from 1516 Hansen Street, Sarasota, Florida 34231 to 170 Groton Road, Shirley, Massachusetts 01464. The Members therefore wish to delete Article 4 of its Articles of Organization in its entirety and replace it as follows:

**ARTICLE 4
STREET ADDRESS OF PRINCIPAL OFFICE**

The mailing address of the Company is 170 Groton Road, Shirley, Massachusetts 01464; and the street address of the principal office of the Company is 170 Groton Road, Shirley, Massachusetts 01464.

FOURTH: The Members wish to change the number of Managers from one to two, and to remove the initial Manager, Sarah B. Allen, whose address is 1516 Hansen Street, Sarasota, Florida 34231, and to add David Bortell and Rita Bortell, whose address is 170 Groton Road, Shirley, Massachusetts 01464 as Co-Managers in her place. The Members therefore wish to delete Article 5 of its Articles of Organization in its entirety and replace it as follows:

**ARTICLE 5
MANAGEMENT**

The Company shall be managed by two managers. The names and addresses of the persons who shall serve as managers until the next meeting of members or until their successors are elected and qualified are as follows: David Bortell, whose address is 170 Groton Road, Shirley, Massachusetts 01464, and Rita Bortell, whose address is 170 Groton Road, Shirley, Massachusetts 01464. The managers shall be elected as provided in the Operating Agreement.

FIFTH: This Amendment was unanimously approved by all Members of the limited liability company.

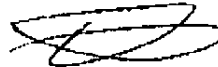
