**ARTICLES OF ORGANIZATION  
OF  
BGHHLF, LLC**

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

**ARTICLE I**

**Name**

The name of the limited liability company shall be: **BGHHLF, LLC.**

**ARTICLE II**

**Address and Place of Business**

**ARTICLE III**

**Period of Duration**


**ARTICLE VIII**


