ARTICLE I Name and Principal Place of Business

The name of this limited liability company is WE'RE IN LUCK, LLC; the physical address of its principal office is 6233 Kingbird Manor, Lithia, Florida 33547, and its mailing address is the same.

ARTICLE II Purposes
