**ARTICLES OF ORGANIZATION
OF

MANAGEMENT (MANAGEMENT BY THE MEMBERS)**

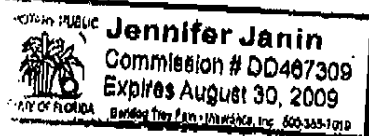
