# ARTICLES OF ORGANIZATION OF TODD PERSONS COMMUNICATIONS CONSULTANTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledge and files the following Articles of Organization.

#### **ARTICLE I**

Name. The name of the limited liability company shall be TODD PERS COMMUNICATIONS CONSULTANTS, LLC (the "Company").

#### **ARTICLE II**

Address. The mailing address and street address of the principal office of the Company shall be 1030 North Orange Avenue, Orlando, Florida 32801.

#### **ARTICLE III**


