**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be TODD PERSONS COMMUNICATIONS CONSULTANTS, LLC (the "Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 1030 North Orange Avenue, Orlando, Florida 32801.

ARTICLE III


