ARTICLE II - PRINCIPAL OFFICE

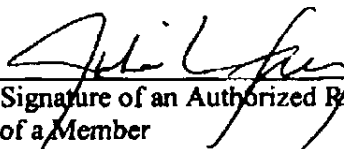
The mailing address and the street address of the principal office of the Company is 1608 West Ivanhoe Boulevard, Orlando, Florida 32804.
