**ARTICLES OF ORGANIZATION OF
WOODLAND ACQUISITION, LLC**

The undersigned, HARRY B. STACKHOUSE, a natural person competent to contract and an authorized representative of a member of WOODLAND ACQUISITION, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I

The name of the limited liability company is:

WOODLAND ACQUISITION, LLC

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the principal office of the Company is 208 Sabine Drive, Pensacola Beach, Florida 32561, and the mailing address of the Company is Post Office Box 579, Gulf Breeze, Florida 32562.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Limited Liability Company Act.

ARTICLE IV – COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Secretary of State, and the Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Company is 125 W. Romana Street, Suite 800, Pensacola, Florida, 32502, and the name of the initial registered agent of the Company at that address is Harry B. Stackhouse.

ARTICLE VI – MANAGEMENT

The Company shall be managed by its members as provided in the Company's Operating Agreement. The name and address of the initial member of the Company are as follows:


ARTICLE VII – RESTRICTION ON MEMBERSHIP


