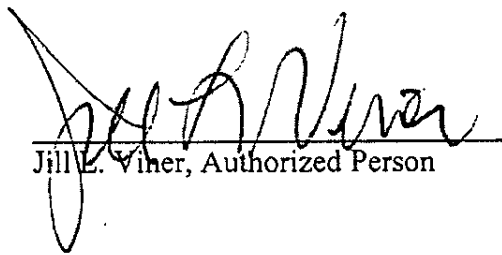
ARTICLE I – Name
