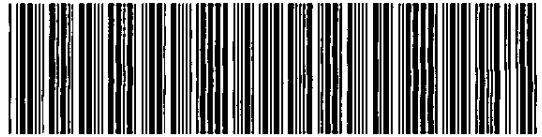



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be **DUNNIGAN PROPERTY HOLDINGS, LLC.**

ARTICLE II

ADDRESS

The mailing address and street address of the principal office of the company shall be 700 Monty Circle, Panama City, Florida 32405.

ARTICLE III

DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV

REGISTERED OFFICE AND AGENT

ARTICLE V

CAPITAL CONTRIBUTION

Each member shall make additional capital contributions to the company as set forth in the Regulations..

ARTICLE VII

ADMISSION OF NEW MEMBERS


ARTICLE IX


