Pursuant to Section 608.411 of the Florida Limited Liability Act, the undersigned, on behalf and in the name of AUTO BODY SPEED SHOP OF JACKSONVILLE, LLC, a Florida limited liability company (the "Company"), adopts these Articles of Amendment.
