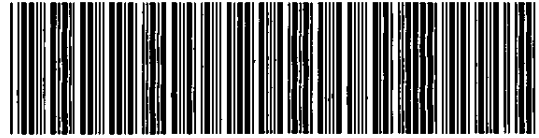

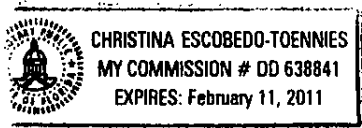



LETTER OF WITHDRAWAL / RESIGNATION FROM PARTNERSHIP

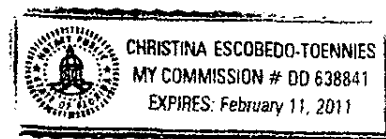
