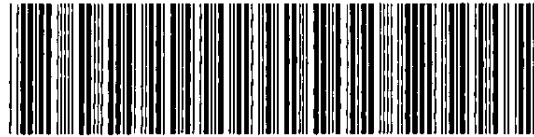


ARTICLE 5.
