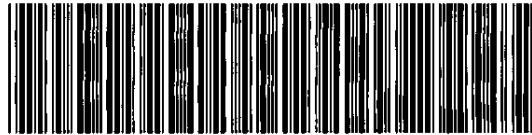

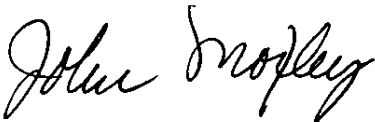

The undersigned, acting as organizer of a limited liability company under the State of Florida Limited Liability Company Act, adopt the following Articles of Organization for such limited liability company:

**I.  
Name**

The duration of the Limited Liability Company's existence shall be perpetual.

**IV.  
Purpose(s)**

A. The purpose for which this limited liability company is organized is to transact any and all lawful business for which limited liability companies may be

B. The foregoing shall be construed as objects, purposes, and powers, and enumeration thereof shall not be held to limit or restrict in any manner, the powers hereafter conferred on this limited liability company by the laws of the State of Florida.

C. The Company may, in its operating agreement, confer powers, not in conflict with law, or its managers and members in addition to the foregoing and in addition to the powers and authorities expressly conferred on them by statute.
