ARTICLES OF ORGANIZATION OF

HJ COMPANY OF NORTH FLORIDA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I: Name

The name of the limited liability company is HJ COMPANY OF NORTH FLORIDA, LLC (the Company).

ARTICLE II: Address

The mailing address and street address of the principal office of the Limited Liability Company is 12412 San Jose Boulevard, Suite 405, Jacksonville, Florida 32223.

ARTICLE III: Registered Office and Agent

The name and Florida street address of the registered agent are:

M. Todd Holder 12412 San Jose Boulevard, Suite 405 Jacksonville, Florida 32223.

Having been named as registered agent and to accept service of process for the abovenamed limited liability company at the place designated in this Certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. ARTICLE IV: Management

ARTICLE V: Duration

ARTICLE VI: Purposes and Powers

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE VII: Admission and Withdrawal of Members

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company. The events which shall cause voluntary or involuntary withdrawal of a member shall be only as specified in the Operating Agreement.

ARTICLE VIII: Termination of Existence

ARTICLE IX: Articles and Operating Agreement

The Operating Agreement shall be adopted by a majority in interest of the members. Except as otherwise provided herein and in the Operating Agreement, the Operating Agreement and these Articles of Organization may be amended from time to time with the written consent of a majority in interest of the members, provided, however, that Articles VII and VIII of these Articles of Organization may be amended only upon the unanimous consent of all the members.
