Articles of Organization

THE TRAVELER - SJB, L.L.C. a Florida Limited Liability Company

The undersigned Member hereby files these Articles of Organization in order to form a limited liability company under the laws of the State of Florida.

ARTICLE I.

Name

The name of this Limited Liability Company shall be **THE TRAVELER - SJB, L.L.C.**

ARTICLE II.

Address

Company Purposes & Powers


