ARTICLES OF ORGANIZATION OF VALENCIA REALTY, LLC

ARTICLE I Name

The name of this limited liability company is VALENCIA REALTY, LLC.

ARTICLE II Existence

This limited liability company shall have perpetual existence.

ARTICLE III Purpose

This limited liability company is created for any lawful purpose (except that special statutes for the regulation and control of specific types of businesses shall control when in conflict herewith) and for the benefit of its members and such business as may be agreed on by its members.

ARTICLE IV Registered Agent and Address

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member of this limited liability company, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall not result in the dissolution of this limited liability company. Rather, the remaining members of the limited liability company shall have the right to
