The undersigned, acting as organizer and as a Member or authorized representative of a Member of SEPTIMUS, LLC under Section 608.407 of the Florida Limited Liability Company Act, hereby adopts the following articles of Organizations:

ARTICLE I.

NAME

Except as specifically authorized by the Managers, no Member of the company is an agent of the Company or has the authority to make any contracts, enter into any transactions, or otherwise make any commitments on behalf of the Company.
