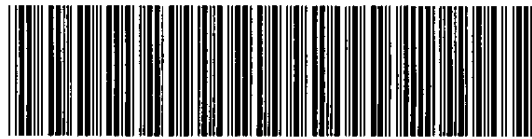

Admission of Additional Members

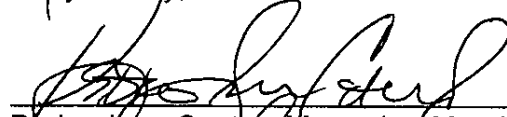
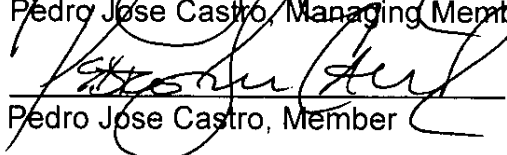

Continuation of Business

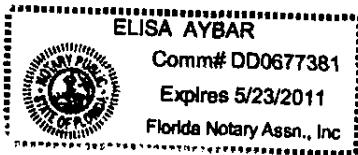

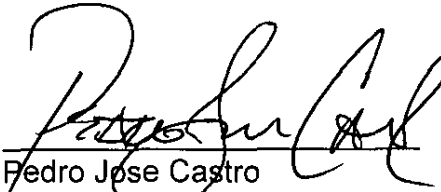
