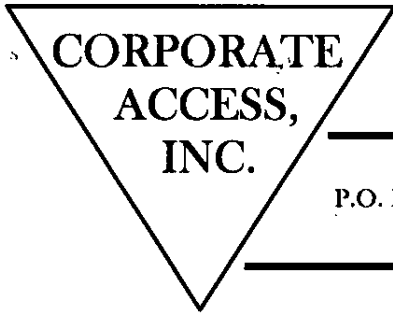


ARTICLE IV — MANAGEMENT


