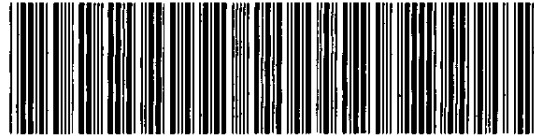

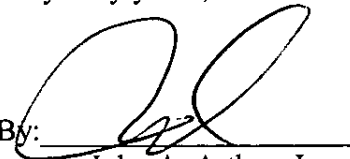

ARTICLE I – Name:

ARTICLE VI – Registered Office and Agent:

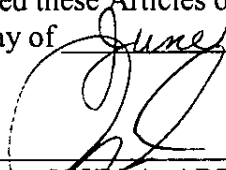
