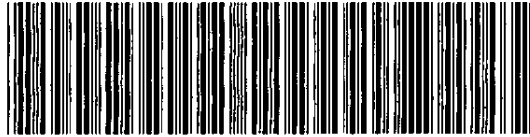

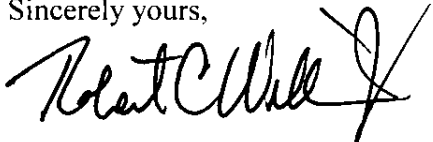

**ARTICLES OF ORGANIZATION  
OF  
HEALTH CONNECTIONS, LLC**

The undersigned organizers of a limited liability company, being competent to contract, subscribe to these Articles of Organization to form a limited liability company under the laws of the State of Florida.

**ARTICLE I - Name**

The name of the limited liability company shall be: HEALTH CONNECTIONS, LLC.

**ARTICLE II - Principal Office and Mailing Address**

The principal office of the company is located at , and the mailing address of the company is: 117 Camelot Ridge Drive, Brandon, Florida 33511.

**ARTICLE III - Initial Registered Office and Agent**

The name of the initial registered agent of this company is Robert C. Wilkins, Jr., and the street address of the initial registered office of this company is 341 N. Maitland Ave., Suite 346, Maitland, Florida 32751.

**ARTICLE IV - Business and Activities**

The company may, and is authorized to, engage in any activity or business permitted under the laws of the United State and of the State of Florida.

**ARTICLE V - Purpose**

The purposes for which the company is organized are:

- (a) To acquire by purchase, lease, devise or otherwise, any and all real and personal property as shall be contributed to the company by any or all of the incorporators, any third person or company and to own, hold, improve, develop and manage any such real or personal property so acquired and to erect or cause to be erected on any lands owned, held or occupied by the company or any other person or persons,

buildings or other structures, public or private, either their appurtenances, and to manage, operate, lease, rent, rebuild, enlarge, alter or improve any buildings or other structures now or hereafter erected on any real property so owned, held or occupied and to encumber or dispose of any real or personal property or interest in any buildings or other structures, at any time owned or held by the company.

- (b) To buy, sell, mortgage, exchange, leasehold, for investment or otherwise, use and operate, real or personal property of all kinds, improved or unimproved and any right or interest therein.

#### **ARTICLE VI - Contribution**

The total amount of cash and real or personal property other than cash, which shall comprise the initial contribution to the limited liability company shall be those items of real or personal property listed on Exhibit "A" attached hereto and incorporated herein by reference.

There shall be no additional contributions made by members of the limited liability company upon the organization thereof and any additional contributions shall be made only upon mutual and unanimous consent of the members. No additional members shall be added to the company without the mutual and unanimous consent of all present members.

#### **ARTICLE VII - Effective Date; Term of Existence and Operation**

The effective date upon which this company shall come into existence shall be the date these articles are filed with the Secretary of State, and the period of duration of the company shall not exceed 30 years from the effective date hereof.

The limited liability company shall be entitled to operate in accordance with such power as are enumerated in Chapter 608 Florida Statutes.

#### **ARTICLE VIII - Members**

A. Management of the limited liability company is reserved to the members whose names and addresses are as follows: ELIZABETH THRASHER, 117 Camelot Ridge Drive, Brandon, Florida 33511.

B. The company shall be managed by ELIZABETH THRASHER, whose address is 117 Camelot Ridge Drive, Brandon, Florida 33511, who shall serve as manager until her successor is elected by the membership.

C. The manager shall prepare an accounting of all income receipts and expenditures of the company for a report to the membership not less than annually.

These Articles of Organization may be amended in the manner provided by law.

#### ARTICLE X -Regulations

The power to adopt, alter, amend or repeal regulations of this company shall be vested in the members of this company.

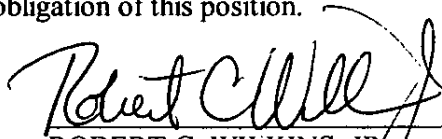
