

**ARTICLES OF ORGANIZATION
FOR
MADISON TITLE GROUP, LLC**

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be:

MADISON TITLE GROUP, LLC

ARTICLE II

ADDRESS

The mailing address and street address of the principal office of the company shall be: 11125 Park Boulevard, Suite 104-222, Seminole, Florida 33772.

ARTICLE III

DURATION

The company shall begin its existence on the date that these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE IV

REGISTERED OFFICE AND AGENT

The name and street address of the registered agent for the company in the State of Florida is: Jimi A. Barfield, 4230 Deltona Boulevard, Spring Hill, Florida 34606.

ARTICLE V

CAPITAL CONTRIBUTION

The members of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

ARTICLE VI

ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.

A member may transfer his or her interest in the company according to regulations as set forth in the company's operating agreement. A transferee other than the manager shall have no right to participate in the management of the business affairs of the company unless otherwise stated in the operating agreement.

ARTICLE VIII

TERMINATION OF EXISTENCE

On the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, the business of the company shall be continued by the consent of all the remaining members.

ARTICLE IX

MANAGEMENT



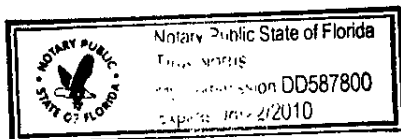


