ARTICLE III

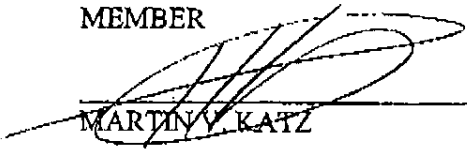
