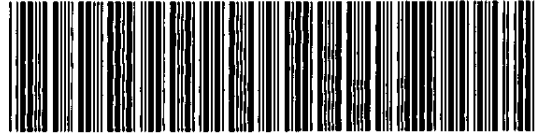



NAME
