Annual report for Stephen J Cutler-LLC and Notice of Dissolution

4/20/09- LLC formed for the purpose of obtaining Work Comp Exemption Status for Stephen Cutler, a Florida Registered Residential Contractor RR0067207.

8/10/09- Work Comp ordered Stephen Cutler to have "LLC" added to his Hillsborough County License RR0067207

9/30/09- Hillsborough County Building Department changed the name and issued a new license number- RR001326851; then ordered Stephen Cutler to register the "name change" with the Department of Business and Professional Regulation. The Department denied that request, but suggested they cancel RR0067207 so Stephen J Cutler-LLC could make application for State Examination and provide all the financial requirements to be accepted for Examination as if Stephen Cutler was never previously licensed. The Department would not honor the change or RR001326851. Stephen Cutler desired to keep his license RR0067207 and have his appointment as Qualifying Officer approved. The department denied the request stating that the Qualifying Officer would be required to take the State Exam. The fact that Stephen Cutler took the State Exam in 1998 was inadmissible. The RR0067207 license did not have a Work Comp exemption, or Four Thousand Dollars to open a Work Comp Account, and a hold was placed on the license. Stephen J Cutler-LLC could not have it's Hillsborough County License registered with

the State and a hold was placed on the RR001326851 license.

10/8/09- Unable to obtain licensure, or qualification, and having no assets of any kind, The officers of Stephen J Cutler-LLC resigned, and the LLC dissolved in insolvency as a result of being prohibited from practicing construction of any kind.

I started this expecting to earn Paychecks. Instead I am getting Food Stamps! Before all these regulations I was a productive Citizen. I am now a (barely)living example of "Job Killing Legislation".
