TO THE  
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 605.0202 of the Florida Limited Liability Company Act, the Articles of Organization of TIDEWELL HEALTH SERVICES, LLC, a Florida limited liability company (the "Company"), filed on July 22, 2009 and assigned document number L09000070840, are hereby amended as follows:

A. The name of the Company shall be amended from TIDEWELL HEALTH SERVICES, LLC TO CONNEXIS MEDICAL SERVICES, LLC.

B. The following paragraph in Article 6, Section B,

"The specific nature, objects, and purposes of the Company shall be to provide a comprehensive continuum of services for patients and families dealing with health and medical issues, including but not limited to services for palliative care, and to otherwise support the charitable purposes of Tidewell Hospice, Inc., a Florida not-for-profit corporation."

shall be amended to read as follows:

"The specific nature, objects, and purposes of the Company shall be to provide a comprehensive continuum of services for patients and families dealing with health and medical issues, including but not limited to services for palliative care, and to otherwise support the charitable purposes of Stratum Health System, Inc., a Florida not-for-profit corporation ("Stratum"), together with Stratum's subsidiaries, including, but not limited to, Tidewell Hospice, Inc., a Florida not-for-profit corporation."

C. Except as hereby amended, the Articles of Organization of the Company shall remain unchanged and in full force and effect.

D. The foregoing amendment was approved and ratified by the sole Member of the Company effective April 6th, 2017 in accordance with Section 605.04073 of the Florida Statutes and the Company's Operating Agreement. Therefore, the Secretary of State is hereby requested to approve and file these Articles of Amendment in accordance with Chapter 605 of the Florida Statutes.
