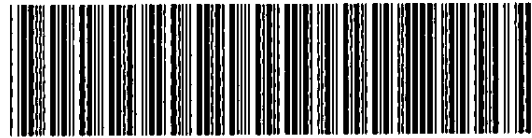

The name of the Limited Liability Company is GOMO, LLC (the "Company").

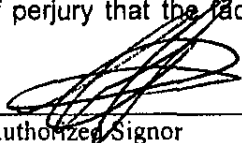

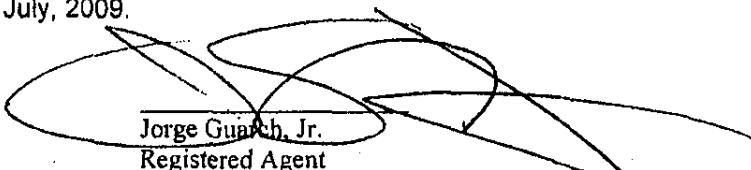
