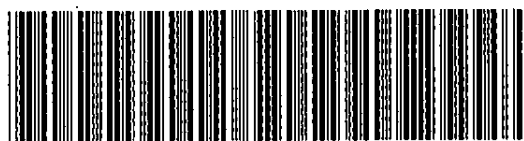

The undersigned, as the authorized representative of the member of the limited liability company which is being formed under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), hereby files the following Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is JFourth, L.L.C. (the "Company")

ARTICLE II

Address

The Company's mailing address and street address of its principal office shall be 115 Colony South Drive, Tarpon Springs, Florida 34689.

ARTICLE III

Registered Agent

The Company's initial registered agent shall be Dominick J. Graziano, whose street address is 101 East Kennedy Boulevard, Suite 1700, Tampa, Florida 33602.

ARTICLE IV

Duration of Legal Existence

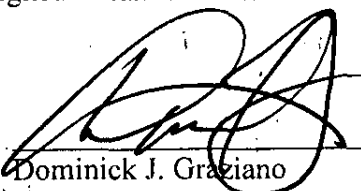
