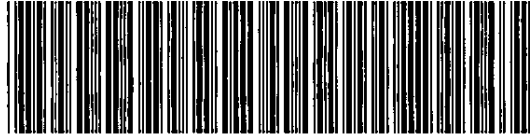

Unless earlier canceled, this Statement of Authority shall be deemed canceled by operation of law five (5) years from the date hereof.


