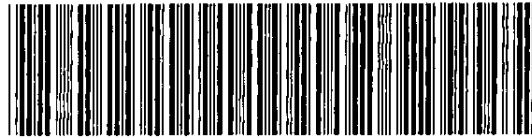

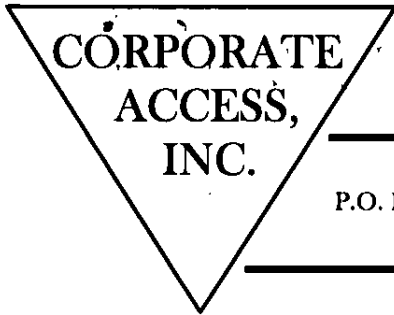

The name of the Company is Cawthon's Medical Supply, LLC.


ARTICLE II - PRINCIPAL OFFICE


