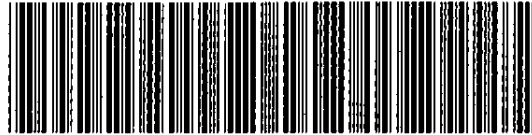

**Name.** The name of this Florida Limited Liability Company is **Karen E. Rybak Legal Nurse Consulting, LLC**.




