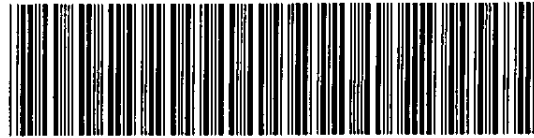

The undersigned, competent and licensed to practice medicine in the State of Florida, acting hereby as Member or Authorized Representative for the Member for the purpose of forming a Professional Service Limited Liability Company, for profit under the provisions of Section 608, Florida Limited Liability Company Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Organization: _____

I

NAME OF LIMITED LIABILITY COMPANY

The name of this Limited Liability Company shall be Victor Morales Hayes, PL.

II

PURPOSES

The general nature and purpose of business to be transacted, promoted and carried on by the Limited Liability Company are as follows:

a. To engage in every aspect of the practice of Medicine and all its' fields of specialization as are engaged in by Physicians.

b. To engage and render the professional services involved only through its' members, agents and employees who shall be Physicians in good standing and duly licensed or otherwise legally authorized within the State of Florida to

render the same professional service as this Limited Liability Company.

c. To invest its' funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.

d. To engage in no other business other than the rendition of the professional services specified herein.

e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

III

MEMBERSHIP INTEREST

a. The Limited Liability Company is authorized to issue shares of ownership in the Limited Liability Company only to Physicians in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this Limited Liability Company.

b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services as determined by the Limited Liability Company.

DURATION

The Limited Liability Company shall have perpetual existence.

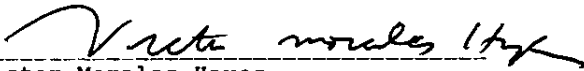

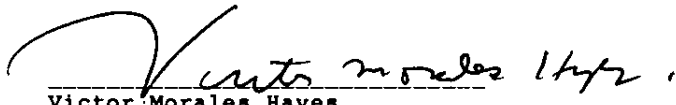
INDEMNIFICATION
