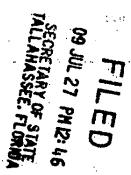

ARTICLES OF ORGANIZATION

OF

Rudd Hawk, LLC.

Under Section 608.407 of the Florida Statutes

THE UNDERSIGNED, being a natural person of at least eighteen (18) year of age and acting as the organizer of the limited liability company (the "Company") hereby being formed under Section 608.407 of the Florida Statutes, certifies that:

FIRST: The name of the Company is Rudd Hawk, LLC.

SECOND: The principal office address and the mailing address of the Company is c/o James D. Rudd at 6300 NW 5th Way, Suite 100, Fort Lauderdale, Florida 33309.

THIRD: The name and street address of its initial registered agent for service of process in the State of Florida is James D. Rudd at 6300 NW 5th Way, Suite 100, Fort Lauderdale, Florida 33309. The foregoing designated registered agent hereby accepts his appointment as registered agent and acknowledges that he is familiar with, and accepts, the obligations of that position as provided for in Florida Statutes Chapter 608.

FOURTH: The Company is formed for any lawful purpose.

FIFTH: The Company is to be managed by two managing members. The managing members shall be James D. Rudd at 6300 NW 5th Way, Suite 100, Fort Lauderdale, Florida 33309 and James Hawkins at 3965 Leafy Way, Coconut Grove, Florida 33133.

SIXTH: A member shall not be personally liable to the Company or its members for damages for any breach of duty as a manager, except for any matter in respect of which such member shall be liable by reason that, in addition to any and all other requirements for such liability, there shall have been a judgment or other final adjudication adverse to such member that establishes that such member's acts or omissions were in bad faith or involved intentional misconduct or a knowing violation of law or that such member personally gained in fact a financial profit or other advantage to which such member was not legally entitled or as otherwise provided by Chapter 608 of the Florida Statutes.
