ARTICLES OF ORGANIZATION OF KONCHICORI MULTIMEDIA LLC

BOME PARTIE The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be KONCHICORI MULTIMEDIA LLC (Company).

ARTICLE 2 – ADDRESS

The principal place of business of the Company is Florida shall be 410 20th Street, Ste. 203, Miami Beach, Florida 33139 and the mailing address shall be 301 Port Augustine Circle, Ste. 202, Ocoee, Florida 34761.

<u>ARTICLE 3 - EFFECTIVE DATE</u>

<u>ARTICLE 10 – INDEMNIFICATION</u>

The Company shall indemnify managers and/or members of the Company who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the managers and/or members was a party because the managers and/or members is or was a manager and/or member of the Company against reasonable attorney fees and expenses incurred by the managers and /or members in connection with the proceeding. If any worked, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be other wise affected. All reference in theses Articles of Organization to "member", "manager", "employee", and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
