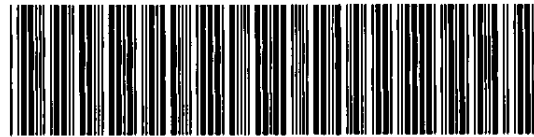

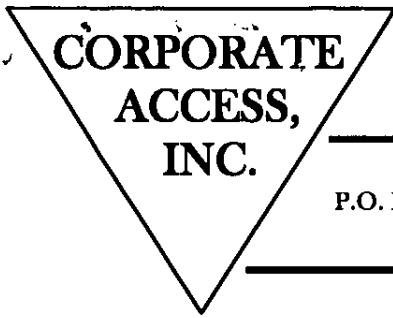

The undersigned being the sole Member of Tampa Children's ENT LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is Tampa Children's ENT LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective July 23, 2009.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I.
NAME

"The name of the Limited Liability
Company shall be HOTCHKISS LLC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
5. These Articles of Amendment have been approved by unanimous Written Action of the sole Member dated January 28, 2010, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
